

## 2012-13 FINANCIAL AID APPLICATION CHECKLIST

Applications for financial aid are not complete until **all** the following items have been submitted. Students' eligibility for aid cannot be evaluated until the aid application is complete. Much of the financial aid budget is allocated by the end of May. Late applicants should contact the Office of Admissions to learn about current aid availability.

### By February 1, 2012:

- Complete the Parents' Financial Statement (PFS)** online at: <http://sss.nais.org>. Charles Wright's school code is 2314. (Available November 1, 2011) **If your taxes are not complete, complete the PFS using estimates.** If you have applied previously some of your information will automatically populate the form. You may also download a paper copy and mail it to School and Student Services (SSS).

### By March 1, 2012:

**You must complete the following items and send to SSS electronically or by mail (with the SSS coversheet):**

- Copy of 2011 Federal Tax Form 1040 **with all supporting schedules and forms**
- Copy of 2011 W-2 Form(s)
- Copies of tax returns, if any were filed, for the children for whom you are applying for financial aid

**You must mail to CWA:**

- IRS Form 4506-T, "Request for Copy of Tax Form". Complete items 1-4 and the signature block, but please do not date the signature. Do not include any fee. [Click here](#) for this form.

**We invite you to attend our financial aid workshop held at CWA**

**ATTN: Owners/Part-owners of businesses, farms, partnerships and/or corporations must also submit:**

- Copies of the following documents as appropriate for your situation:
  - Schedule C: Sole proprietors
  - Schedule F: Profit or Loss from Farming
  - Form 1065: US Tax Return of Partnership Income
  - Form 1120: US Corporation Income Tax Return
  - Form 1065 or 1120S Schedule K-1
  
- Copies of any other documents submitted as part of your tax return or in support of your tax return.

**ATTN: Military Families**

If one or both parents are in the military, a copy of your December 2011 leave and earnings statement(s) must be submitted.

**ATTN: Parents who are Divorced/Separated/Never Married:**

Charles Wright Academy requires both parents to participate in the financial aid application process. Hence, we ask both parents to submit tax documents and submit a PFS. Please contact the Admissions Office if either parent needs additional information or instructions.

**Tips for Completing the PFS:**

1. **Submit the Parent Financial Statement (PFS) ONLINE.** SSS accepts both on-line and paper form submission. We recommend online submission because the fee you pay is slightly lower and the data gets to Charles Wright more promptly.
2. **Read the instructions for each item.** The instructions will answer most questions but if you have questions about how to fill in the PFS, you can direct questions to the SSS Customer Service Center by calling (800) 344-8328 Monday-Friday 9am-8pm; Saturday 9am-4pm. (All times EST)
3. **Special Circumstances. We recognize that every family's financial reality is unique.** For special circumstances not covered by the PFS, we encourage you to send a separate written explanation to the Admission Office.
4. **Provide copies of your complete tax return.** After you complete the PFS online, you may upload your tax documents. This includes not only the form 1040 but also **all** W-2's, schedules, and forms – in short, any form you submitted to the IRS as part of your return, or that you completed in support of your return. If you have questions about whether Charles Wright requires a form, please call the Admissions Office.
5. **Keep copies of all financial aid forms and supporting documents.**
